

Keynote Speaker for the 2014 Meeting: Dr. Carol A. Newsom Candler School of Theology and the Graduate Division of Religion at Emory University

"At Home or Homeless? The Wisdom Tradition and Contemporary Philosophy on the Problem of Evil"

Professor Newsom holds an MTS from Harvard Divinity School (1975) and a PhD from Harvard University, the Department of Near Eastern Languages and Civilizations (1982). Since 1980 she has taught Hebrew Bible at the Candler School of Theology and the Graduate Division of Religion of Emory University. In 2005 she was named to be a Charles Howard Candler Distinguished Professor at Emory University in recognition of excellence in research and teaching. She currently serves as the Director of the Graduate Division of Religion. Professor Newsom's scholarly interests are broad, serving as a member of the international team of translators of the Dead Sea Scrolls (as the first woman to be named to the team) and recently producing a monograph entitled The Self as Symbolic Space: Constructing Identity and Community in the Dead Sea Scrolls (Brill, 2004; SBL, 2007). She is also a scholar of the wisdom literature, having published a commentary on the book of Job (in the New Interpreter's Bible Commentary series with Abingdon Press) and a monograph, The Book of Job: A Contest of Moral Imaginations (Oxford University Press, 2003). She also has co-edited with Sharon Ringe and Jacqueline Lapsley The Women's Bible *Commentary*, a revised and expanded 20th anniversary edition of which appeared in 2012.

Minutes of Business meeting Central States SBL, March17-18, 2013 St. Louis, Missouri

Agenda

Minutes of last meeting (2012): Approved as read. Reports: President's report.

1. Report of online difficulties; was given Samantha Spitzner's email: samantha.spitzner@sbl-site.org.

 Admonished the society about the lateness of registration and room reservation. Treasurer's report: Prereg: 51; on-site, Prereg amount 3156.00; onsite: Total of 654 (as compared with 67 preregistered online last year).
Books: Students need to claim their free books; for others, half price. It is a donation, but it helps the society. Society needs the help by members buying the books. Our numbers for this year are down. Last year we preregistered 67 as compared with 51 this year (but we sold 48 banquets last year as opposed to 55 this year). Our initial intake this year was 3156.00, so we are a little low. We'll see how everything shakes out when we get all of the data in.
This year's publishers: Hendrickson, Zondervan, Baker, IVP. Moyer:

Concerned that Abingdon is not here. Last week Abingdon was selling the NIDB at 75% off at the Southwest regional meeting. They want to move the NIDB, so write them to see if they will do it.
